**NOTICE:** Any purchaser and/or agent who fraudulently signs this certificate without intent to use the property or services purchased as above stated is subject to all the penalties provided for by Title 47 of the Louisiana Revised Statutes of 1950. This certificate will remain in effect until withdrawn by the purchaser, or the purchaser's sales tax account is closed, or the purchaser's ability to make tax-free purchases is amended or revoked by the Ascension Parish Sales and Use Tax Authority.

### INSTRUCTIONS - SALES & USE TAX EXEMPTION CERTIFICATE

Use this form to claim exemption from sales tax on purchases of taxable items. The purchaser must complete all fields on the exemption certificate and provide the fully completed certificate to the seller in order to claim exemption.

**Purchaser:** You are responsible for ensuring that you are entitled to the exemption you are claiming. *It is your responsibility to inform the seller if any part of the transaction is taxable.* You will be held liable for any tax and interest, as well as penalties imposed by the Ascension Parish Sales and Use Tax Authority, if you are not eligible to claim this exemption.

**Seller:** You are required to keep a copy of this exemption certificate in your files and provide information on the purchaser to any local taxing jurisdiction upon request. You are relieved of the responsibility for collecting and remitting sales tax on the sale or sales described on the exemption certificate, provided all of the following conditions are met:

1. all fields on the exemption certificate are completed by the purchaser.
2. the fully completed exemption certificate is provided to you at the time of the sale; and
3. you do not fraudulently fail to collect the tax due or solicit customers to unlawfully claim an exemption.

Complete the purchaser and seller information section. An identification number for your business must be included. Also, include your state tax identification number.

This is a local exemption only; state sales tax may apply. A separate state sales tax exemption is required. This exemption applies to the local sales tax only and cannot be used to exempt the State of Louisiana sales tax.

Dear Mr. Ashworth,

Williams Olefins, Inc., LLC (account number 5262) has Direct Pay status for all local sales taxes collected by the Ascension Parish Sales and Use Tax Authority. It is also understood that Williams Olefins, Inc., LLC (previously known as Union Texas Products) has held this status prior to the creation of the Authority in 1990. Direct Pay status means Williams Olefins, Inc., LLC shall remit directly to the Authority local sales and use tax due on the purchase, importation, or lease of tangible personal property or on the purchase of taxable services. Your vendors and lessors shall not be responsible for collecting sales and use tax on such sales or leases upon the presentation of your valid Direct Pay Exemption Certificate, provided that the vendor or lessor notes the Direct Pay Permit number on the untaxed contract or invoice submitted to Williams Olefins, Inc. LLC

This Direct Pay Permit applies only to transactions made by Williams Olefins, Inc., LLC and are accounted for under account number 5262. It does **not** include any transactions made by subsidiaries, divisions, or other related companies of Williams Olefins, Inc., LLC that are not accounted for under this sales tax accounts number. Also it does **not** apply to transactions made by contractors working for your company.

The Direct Payment Permit may **not** be used for the following transactions:

- 1) Taxable services performed outside of Ascension Parish (including repairs,)
- 2) Taxable sales picked up outside of Ascension Parish, and
- 3) Taxable leases or rentals transacted outside of Ascension Parish.

Enclosed is a supply of Direct Pay Exemption Certificates. These are "blanket certificates" and only, need to be submitted once to each vendor. Your Direct Pay Permit Number is 5262 - 019.
