A copy of any Direct Remittance Certificate issued to any vendor must be forwarded to the Iberville Parish Sales Tax Department. This Direct Remittance Certificate applies to Iberville Parish sales/use/rental tax only. Furthermore, the certificate granted to this location cannot be used to make purchases from any other location of this business entity. Please note that you cannot use this certificate for repairs done outside Iberville Parish.

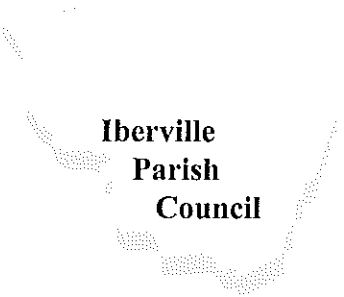

Failure to do so will subject your Direct Remittance Certificate to revocation, civil and criminal penalties provided for in the Louisiana Revised Statutes and Iberville Parish Sales Tax ordinance.

This Iberville Parish Direct Remittance Certificate is issued based on your current qualifications provided to the Department of Revenue, State of Louisiana. Iberville Parish Sales Tax Department reserves the right to periodically review your records with the state to determine if the minimum qualifications are being maintained. If at any time in the future the required qualifications are not met, the Direct Payment number may be revoked.
